Our Mortuary is located at 33 Warren Avenue, Bankstown and is registered with the NSW Health Department. It is checked by the Bankstown Council Health Department annually to meet health requirements.

We use a privately owned and operated crematorium for most No Service - No Attendance Cremations. Family has the option of choosing a different facility if desired.

Additional fees may apply.

Transportation of the deceased prior to burial or cremation will be in a suitable vehicle owned and operated by Lady Anne Funerals. The deceased will be kept in our refrigerated holding room and will only be transported for the purposes of the funeral service as per the funeral agreement.
